The Board of Education of School District 08-0051 met on Wednesday, August 26, 2026, for a Special Meeting & Board Budget Workshop. The roll was called by Chairperson Nelson at 7:00 p.m. with members Alford, Boettcher, Bernt, Black, Higgins, and Nelson present.

This meeting is being conducted in compliance with the NE Open Meetings Law 87.107 to 84.114. A copy of this law is posted in the meeting room.

Bernt moved, "That the agenda for this meeting, all items of which were placed on it at least 24 hours prior to the meeting time as provided by statute, be accepted as presented," seconded by Alford. Ayes-6. Nays-0. Carried 6-0.

Higgins moved, "To approve the financial reports (Activity Fund, Hot Lunch Fund, Financial Summary CDs, ICS, Depreciation Fund, Revenue Summary Sheet, QCPUF, Special Building, Employee Benefit, and CICF) of the Boyd County School district 08-0051," seconded by Boettcher. RCV. Yeas-6. Nays-0. Carried 6-0.

Alford moved, "To approve the bills, claims, and transfers for Boyd County School District 08-0051 on the General Fund," seconded by Higgins. RCV. Ayes-6. Nays-0. Carried 6-0.

Mr Thompson reported on Football Field sprinkler installed and working, transportation, Ag shop wiring update complete other than new breaker install, Sept 4th early out for football game, compiling list of architects to explore options.

Alford moved, "To increase classified sub pay from \$105 to \$125 and certificated sub pay from \$125 to \$145" seconded by Bernt. RCV. Ayes-6. Nays-0. Carried 6-0.

Higgins moved, "To purchase 2015 Ford Girardin 14 Passenger Van from American Bus for \$51,585." seconded by Alford. RCV. Ayes-6. Nays-0. Carried 6-0.

Mr. Thompson discussed the current budget results for the 2025-2026 school year as well as future budget planning. Will look into moving funds from the special building fund from proposed budget to the general fund and report back to the board.

The Special Meeting and Budget Workshop was adjourned by President Nelson at 7:55 p.m.
