ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I hereby assume all of the risks of participating in this Sports Camp, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

I certify that I am physically fit and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this Sports Camp. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the organizers of the Sports Camp and that it will govern my actions and responsibilities at said Sports Camp.

In consideration of my application to participate in this sports camp, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and agree to the following:

(A) I WAIVE, RELEASE, AND DISCHARGE the entities or persons listed herein from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this Sports Camp. ENTITIES OR PERSONS include: Aaron Schmitz, and/or his coaches, agents, representatives, and/or volunteers.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned herein regarding all liabilities or claims made as a result of participation in this Sports Camp, whether caused by negligence or otherwise. I acknowledge that this Sports Camp may carry with it the potential for death, serious injury, and personal loss. The risks may include, but are not limited to, those caused by terrain, facilities, exercises, physical stress, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, and lack of hydration. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
